Pursuant to B.M.C. 3.17.030; the Tax Administrator is amending subsection (A) of Section 3.17.070 as follows:

- A. The cannabis business tax imposed by this chapter shall be imposed on a quarterly basis, payable quarterly, and remitted no later than forty-five calendar days after each quarter end.

Moreover, on the authority provided in Banning Municipal Code Section 3.17.070(D), the Tax Administrator is amending subsections (A), (B), and (C) of Section 3.17.030 as follows:

- A. There is established and imposed upon each person who is engaged in business as a cannabis business a quarterly cannabis business tax at the rates set forth in this chapter.
- B. Every person operating a cultivation facility shall pay to the city a quarterly cannabis business tax in an amount that is equal to fifteen dollars per square foot of canopy space per year (three dollars and seventy-five cents per quarter). The city council, in its discretion, may adjust the tax rate up to a maximum rate of twenty-five dollars per square foot of canopy space.
